#### SECTION 3 HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW – Black thin viscosity liquid with mild Ethereal odor. Warning! Flammable liquid and vapor. Keep away from heat sparks and flames. May cause eye, skin and respiratory tract irritation. If swallowed do not induce vomiting. Get immediate medical attention.

#### Extinguishing Media -
