EMERGENCY OVERVIEW

Clear green liquid mixture, with glycol ether mixture odor. Caution! Irritant liquid and Vapor, Flash Point: 65°C. Contact with liquid may cause severe eye irritation. POTENTIAL HEALTH EFFECTS
